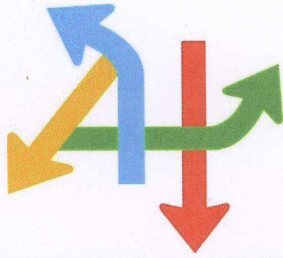

Rinse and remove caps. All colors can be mixed. Labels need not be removed.



### BEVERAGE CANS

Please rinse.



### MAGAZINES & CATALOGS

Glossy paper, glossy junk mail.



### #1 - #7 PLASTICS

Plastic bottles, such as milk jugs, pop bottles, shampoo and detergent bottles. Clamshells and containers such as those used for salad, cottage cheese, yogurt, and berries. No Styrofoam.



### TIN/STEEL CANS & ALUMINUM SCRAP

Pet food cans, fruit and vegetable cans, etc. Aluminum foil, pie pans and other small scrap. Material must be free of food. Labels need not be removed.



### PAPERBOARD & CARDBOARD

Cereal boxes, cracker boxes, pop & beer cartons, paper towel rolls, paper egg cartons, etc. Brown corrugated, paper grocery sacks, brown/manila envelopes. Remove plastic inserts and flatten.



### FILM PLASTIC

Number 2 & number 4 film plastics, such as bubble wrap, shrink wrap, bread bags, grocery bags, and sandwich bags.



### MIXED PAPER (NON-GLOSSY)

Letterhead, copy paper, colored paper, non-glossy junk mail, envelopes.

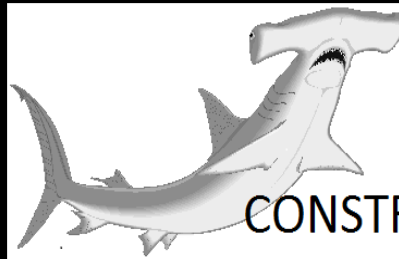

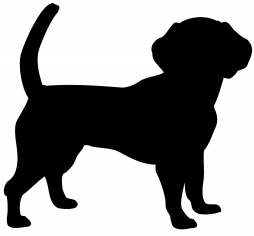
## **Rally for the Cure**

Hello, my name is Carter Foy. I would like to establish a HAH Paw Park Dog Park in Hide-A-Way Hills.

My travels in different cities have allowed me to see many dog and people friendly "parks".

The first dog and people friendly park (I saw) was in Del Mar, CA. We were there 25 years ago. So dog parks are not "new". It was a dog beach on the sand and ocean. This area had dog "poop" containers. There was not one single poo on the sand. That is because the Californians pick up trash. The dogs were chasing Frisbees, balls, play toys on the sand and into the ocean. The waves there are gentle because of the curve of the bay. Patrick and I took photos of dogs and owners playing and I noticed that when dogs are running and playing and exercising, there was no "discord" among the dogs because they are so happy to be able to run. Del Mar Dog Beach is next to a busy highway and parking was at a premium. The dog owners put the leashes on their dogs to enter and exit the beach.

The second large dog park we visited was in Philadelphia, PA. We took our "granddog", Belle to run and play. This dog park was nestled in between a highly populated neighborhood and built on a slightly graded area and had trees. It also had a huge black PVC pipe that the dogs could run in and out of along with ramps and balls made of some sort of rubber than does not degrade upon doggy teeth picking them up. One thing I noticed was a shaded area built of wood for dogs and doggie parents. Also, instead of benches, there were huge long tree "benches" made of trees with a cutout on the top for people to sit. And best - an area for small dogs. Both the large dog and small dog entrances had a double gate (spring loaded doors to shut behind), two for the large dogs and two for small dogs to be able to enter and exit easily.

Robie Snoko, Architectural Designer, has agreed to design the Paw Park!

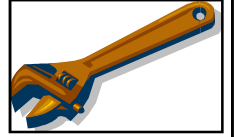

August 16, 2016

**CALL TO ORDER:** The meeting was called to order at 7:00 p.m. by President, Jim Lloyd. In attendance: Valerie Barker, Bucky Childers, Tom Mathews, Greg Ptacin and Ginger Reed, General Manager, Randy Swetnam and Management Committee member, Chas Cross. Excused: Donna Grove, Dave Miller and Marc Holt.

### **ADOPT AGENDA**

Motion to adopt the agenda was made by Dale Young; second by Ginger Reed – **Motion Carried**

### **PRESIDENT'S REPORT – Jim Lloyd**

- In the past few days we have lost two long-term members of HAH, Mike Augustus and Nick Paniccia, please keep Belinda and Sherry and their families in your thoughts.
- This is my last President's Report. I want to thank all of the Board members, past and present, for their support. We did not always agree with each other, but did get a lot accomplished and I am honored to have served as President of the Board of Trustees of Hide-A-Way Hills for the past three years.
- UTVs can now access Harcum Park via the UTV trail, the guidelines are posted, you can pick up key at Security and go up and enjoy yourself, please respect the neighbors. This is a quiet area, it is not a place to party, but a place to have a picnic and enjoy the scenery.
- Do not forget that the Volunteer Appreciation Reception is this Saturday in the Lodge dining room at 3:30pm. Board members please contact your committee chairpersons and if they nominated a Volunteer of the Year, please have them advise these individuals so they will attend to receive their award.
- The Annual Membership Meeting is this Sunday; registration starts at 1pm with the business portion of the meeting beginning at 1:30pm.
- I wish the next Board President only the best during his or her reign. I know with their leadership HAH will continue to grow and prosper.

### **LAKE OF THE FOUR SEASONS REPORT – Chas Cross**

The divers were in yesterday and their primary goal was to perform the dive that allows them to cap the pipe that we need sealed off as part of the valve replacement. The valve has been designed and plans have been made to be able to get the valve out of the spillway, which is not an easy task.

They encountered a rock at the end of what is currently the old emergency spillway; along with that rock we found water. This is the first time they have encountered that scenario so we are in the process of putting together a remediation plan to address that issue. Preliminary models and estimates indicate that we are going to put in what is called a rock drain and then drain it off to the primary spillway, more to follow. Igel submitted this remediation plan to HAH late last week; we had to wait for 2LMN to review as our engineer was on vacation last week. The 2LMN engineer is currently working on the review and she is also working with ODNR for them to approve the plan. As soon as we get this approved plan back, Management will review and approve as soon as possible since this is in a critical path as we dismantle the old emergency spillway and build the new spillway.

The soil that is coming from the borrow area for the most part is completed. They ended up having to go wider instead of deeper with the soil, because when they went down below four feet it appeared that the soil was too wet to effectively use. The option was to come west or deeper in the ORV track, which they did. There is one turn in the center of the ORV track that has a tree and they came all the way out to the tree. We will work with Igel to reconstruct the ORV track when the project is completed.

Igel will start forming the sidewalls to the new emergency spillway so that they can get the concrete poured.

County road repairs between Paniccia's and Sorrell's where the pavement is starting to breakdown as they haul dirt out of the borrow area has been approved and is scheduled to begin this week, weather permitting.

Greg Ptacin question – do they know where the water at bottom of the emergency spillway is coming from? Answer: We know it is not coming from the dam or the lake. As best as they can tell, it is natural spring water or something to that affect. We have not heard a definitive answer, but were assured that it did not appear that it was coming from anything that we were working on or the lake. The piezometers installed in order to monitor any seepage that come from that area, would give us indication that it was coming from the lake and that has not happened.

The project is currently on schedule and Igel has been working on Saturday's whenever possible to keep the project on schedule.

Total Committee funds in the Vinton County National Bank on July 31, 2016 were \$51,911.57. Motion to approve made by Greg Ptacin; second by Ginger Reed – **Motion Carried**

**MANAGEMENT COMMITTEE REPORT – Chas Cross**

- We continue to discuss the office automation system; Jenark and the office staff have had several phone conversations and we plan to revisit this after the first of the year.
- Maintenance has installed new doors going out to the Lodge deck.
- Deck cleaning and staining has been approved and will be completed shortly.
- Patrick Foy presented a recycling proposal that we are moving forward with. That was an item on the member survey that was wanted.
- Long Range Planning Committee, Emergency Action Plan; majority of work is completed and we just need to review to make sure everything is current and up to date.
- North End dredging – we made several attempts to rework the area and get it to where it would start to dry out. As we moved into this year, we had \$25,000 left in the Sediment Trap account and we asked that it be reallocated to the dredging project. We engaged a couple different contractors about what we should and could do to get the area to continue to dry out. It was apparent we needed to get back in with heavy equipment and make provisions for it to dry out. Even after doing that, we had one large area, which is essentially the North dock area that still had cattails which do not go away unless you remove them. Within the last couple of weeks, we removed the cattails and layered that soil back up so it continues to drain and dry out. It has gotten dry enough for us to get equipment into the vital areas. The first two things we did were cleanup and further refine the channel that was dug last year on the Enchanted Forrest side of the area and then we went to the east side and dug another channel. We worked with a couple of the members to take some of the soil and we opened that area up. In the meantime, we brought Igel in to take a look at the area; they are interested in taking a look at it. We had Downard Construction in to exhaust the \$25,000. Our goal is to get that area two to three feet deep clear down to where the silt pond is.
- We would like to request the Board's approval to allocate up to the first \$100,000 of the 2017 amenities monies so that we can continue the project. In the preliminary estimates, \$100,000 represents approximately one-half of the remaining costs to complete what we think we can get done and the remainder of the monies will come from the Capital and Operating funds. We have reached out to all of the committee chairs, we have heard back from most of them, but I do not have final count at this time.
- Motion to approve up to \$100,000 of the amenities monies for the North End dredging project with the stipulation that all of the committee's agree by Greg Ptacin; second by Valerie Barker - Discussion – **Motion Carried**

**GENERAL MANAGER'S REPORT – Randy Swetnam**

- I want to thank Jim Lloyd for his tenure as President of the Board and the help and cooperation that he has given me.
- Delinquency totals at July was \$98,085 for regular assessments and as of this month August \$98,478; Roads as of last month was \$15,119 and as of this month \$18,006.
- Special Dam Assessment account balance as of Monday was \$1,155,998.
- We have changed our Chip & Seal system this year; we are going to a Moto Pave system, which Management approved. Moto Pave is similar to pavement, but they use cold mix, instead of hot mix, and then they cover that with chip & seal. This is going to be done by Shelly Company; we are doing the area between Kusa Lane at the bottom of the golf course hill all the way up to the post office by the Lodge. It will take about a day to do the Moto Pave and it will affect members on Maya Lane, Ute Court, Shawnee, Iroquois, the road back to the garden and Winton Court; members that live on Osage, Natchez and Kusa will have to come and go out the other direction. This will affect members for a couple of days. When they pave they are going to pave the entire lane at one time. You can go behind or in front of them, but you cannot pass them, as they will be taking up the entire lane. We will give members as much notice as possible.
- The Moto Pave project is going to take most our Chip & Seal budget, so the Chip & Seal is going to be bits and pieces; they are going to do the hills first and then they will go to the worst spots. We will only have enough funds to do about two loads.
- Thanks to the Long Range Planning Committee, ODNr has approved four of the smaller lakes Emergency Action Plans, which they have been working on diligently. We are still working to complete the plan for the Lake of the Four Seasons.
- Next month, September 14-15, is the OLCA Fall Meeting. It will be held at Roaming Shores in Ashtabula County. The Board, Management and Committee Chair registration costs will be covered by the Club.

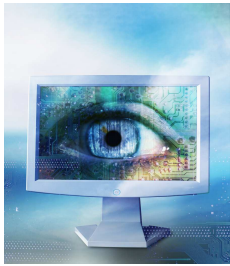
