CPI Increases



The Consumer Price Index (CPI) increased 2.31% last year. This will add \$3.72 a month to the regular monthly assessment making it \$164.69.

The 1/3 assessment will be \$54.90 a month and for a 2/3 assessment it will be \$109.80 a month.

The New Member Fee will increase to \$4,352.56.
